

FMCSA Administrator to Speak at Women In Trucking Conference

FMCSA Administrator Darling to speak at Women In Trucking's Accelerate! Conference and Expo next month.

Scott Darling, administrator of the Federal Motor Carrier Safety Administration (FMCSA) will be an speaking during its opening session of the Accelerate! conference and expo.
