Thank you for your patience while we looked into this. We believe the discrepancy stems from the fact the total number of slack adjusters reported by Gunite as being shipped PACCAR/Kenworth includes parts for installation on vehicles to be manufactured and sold outside the United States. More specifically, 2,544 slack adjusters were shipped to KenMex, 40 shipped to Australia, and 253 to Canada.

The remaining slack adjusters were distributed to the Kenworth plants in Chillicothe, Renton, and St. Therese for installation on chassis intended for sale in the United States. These chassis were the subject of the recall. Multiple slack adjusters were installed on each chassis; therefore, the vehicle count in the recall is less than the number of slack adjusters shipped to these plants.

Peterbilt chassis were not affected by this recall.

Mr. Van Bodegraven,

Good afternoon. Regarding Paccar's 11V-157 recall (Gunite slack adjusters), Paccar/Kenworth recalled a total of 280 U.S. vehicles with these slack adjusters. However, going through Gunite's purchaser lists (attached), Gunite noted that Kenworth was sold 3,491 of these units and Paccar received 807 units. This is a significant difference from the unit count noted in recall 11V-157.

Do you know why there would be this extreme difference in unit counts? We usually expect a small difference between what is reported and what is ultimately recalled by the vehicle manufacturer, but a 4k difference is quite substantial. We'll need to add some sort of written explanation to our recall file.
