# SUBJECT: FL605 - Parts in Recall Kits

If there is a concern about a replacement part with a mold line and lot number that matches a combination from **Table 4**, Suspect Slack Adjuster Lot Number and Mold Line Identification, in the Work Instructions, the information below will allow you to confirm the part is good and should be used.

#### **Visual Identification of Inspected and Certified Parts**

Any Gunite slack adjuster that has passed inspection can be identified by a green dot appearing on the box, on the part, or on both, see **Photos 1**, **2**, and **3** below. In addition, a capital letter "C" at the end of the run number, see **Photo 4** below, also signifies the slack adjuster housing has been certified and may be used.
