Field appraisals require an on-site visit from one of the company's professional licensed appraisers and includes:

- Multi-point vehicle inspection
- Repair quality checkup
- Customized insurance demand/cover letter
- Supporting legal documents
- USPAP compliant valuation report
- Vehicle history report
- IRS form 8283 (for donated vehicles)
- Money back guarantee

In addition to the above, Diminished Value of Georgia will negotiate a settlement on behalf of the client on all first-party appraisal clause disputes at no extra cost.

It is important to note that if the insurance company requires a physical inspection of the vehicle, then a field appraisal will be needed. Also, if the vehicle has significant repair quality issues, a field appraisal may be needed.

This pricing structure applies to all appraisal types offered. Clients residing outside the reach of a field office might accrue a small mileage surcharge.
