Typical Questions about Bureau of Automotive Repair Undercover Cars

Among the common questions asked by automotive repair and SMOG check stations are the following. First, a station owner might be interested in even knowing that the undercover car program even exists. There is quite a bit of disbelief that a state agency is doing something that seems more like an episode of the X-files than common practice by a public agency. Second, they are interested in learning whether they can recognize these vehicles. Third, they are very keen to learn if this is legal, and if so, in what way. Finally, if they receive an official accusation from the Bureau of Automotive Repair, they would like to know how to consult with an attorney as well as how to substantiate that this incident actually occurred and is not being falsified.
