"It is imperative to have uninsured motorist coverage, as an estimated 14.7% of drivers in California are uninsured, according to the Insurance Information Institute."

Arter adds that in addition to liability and collision, uninsured motorist coverage is one of the most important to have in large metropolitan areas. For drivers who do not have uninsured motorist coverage, Arter shares the following three reasons why they should purchase it now:

No. 1: Protection from police-chase collisions. "If a fleeing felon running from the police strikes your vehicle, who's at fault? Usually, felons don't have a great deal of assets and would not be covered if they're in a stolen vehicle because there is no insurance," said Arter. "Even if you're walking and are struck by someone in a stolen car without insurance, if you have uninsured motorist coverage, you get your medical bills paid, and there is allowance for pain and suffering for people injured in a police pursuit."

No. 2: Protection from uninsured bicyclists and skateboarders. If struck by a bicyclist or a skateboarder without insurance, a person that has uninsured motorist coverage is covered and compensated for their injuries. "Even if your children are walking to school and are struck by anything with wheels, you can receive compensation for their medical bills and the pain and suffering," said Arter.

No. 3: Protects passengers. "Uninsured motorist coverage not only protects you after an accident, it protects your passengers as well, whoever they might be," said Arter. "We have liability coverage because it's the law. We have uninsured motorist coverage because it's a smart and responsible thing to do."
