[The Dominator™](#) is a unique and rugged, 12,800 GVW (gross vehicle weight) truck, powered by a 6.0L PSI V8 engine and a R90 6-Speed Automatic Transmission. With military DNA and a rugged powertrain, the Dominator™ has been tested in extreme conditions. As a standard feature, each Dominator™ will be completely covered with Line-X protection that is a polyurea based coating resistant to rust, water, scratches, abrasions or other external influence. The Dominator™ offers a trusted choice in several specialty applications, such as police, fire and rescue and forestry. Alkane’s engineering partners Triad Services Group, are also developing ways to armor plate the vehicles for government and military applications. Alkane will offer the Dominator™ with a propane-powered or gasoline-powered engine. Both propane and gasoline versions perform identically when comparing horsepower and torque.

Since the vehicle weight exceeds 10,000 lbs., the propane-powered version is eligible for tax incentives of up to \$12,000, in certain states.
