What To Do If A Loved One Or Family Member Is Involved In A Vehicular Accident Involving A Semi Truck, Or Commercial Vehicle?

* If you, or a loved one is involved in an accident with a semi truck, big rig, or commercial truck, you should seek medical attention immediately if needed. Never leave the scene of the accident, or admit fault if this can be



avoided.
