In that capacity, he implemented and managed the company's first integrated global Customer Account Management teams, leading to a 70% increase in sales and a positive impact on operating profit of \$1 million in nine months.

Upon the merger of Teletrac and Navman Wireless in late 2014, Ver Eecke assumed the added responsibility of Vice President and Chief Service Officer for the joint business. In that role, he created a combined global services team, implemented a common worldwide organizational structure, unified KPIs on a global level, and drove operational margin expansion, including a 22% year-over-year improvement in the Teletrac customer base.

Renaat Ver Eecke holds a Master's of Business Administration from MIT's Sloan School of Management and a BS from Georgetown University as well as the Catholic University of America.
