Emotional stress, anxiety, shock and humiliation can be proven as types of pain and suffering caused by the accident. Other damages include the plaintiff’s loss of enjoyment of life. In this instance, the injury affects the plaintiff’s lifestyle, hobbies or conveniences. Some damages are not quantifiable, meaning it is very difficult to assess the amount of compensation necessary for each affliction. Because they are subjective, it is important to have each case reviewed by an experienced accident lawyer.
