Roadwork Advisory Report**

Interstate:

Interstate 40 westbound at mile marker 160 (CARLISLE), left lane closed.

Left lane closed on I 40 Westbound at the University Exit from Dec. 20-29 nightly 7 p.m. - 5 a.m. (Nightwork) **No work scheduled on Dec. 24-25.** Contractor, Kelly Cable.

Interstate 40 westbound at Eubank Boulevard right lane closures and on and off-ramp closures.

Dec. 27-29, 2016 between 9 p.m. – 5 a.m. (Nightwork) for street light repairs. Detour: Use Wyoming ramps. Contractor: Atkinson Power.

Interstate 40 at Interstate 25 (Big I) Westbound milepost 159.41; Left lane closed

Dec. 22 - Dec. 29, 2016 7 p.m. – 5 a.m. (Nightwork) Kelly Cable will be performing utility work in the area. Motorists reduce speed to 55 mph in workzone.
