Roadwork Advisory Report – October 5th, 2017 through October 13th, 2017

Interstate:

I-40 eastbound Project A300078R: (NO Lane restrictions during AIBF)

Through January 2nd, 2018; Monday through Sunday I-40 eastbound will have continuous left lane and shoulder restrictions in place for concrete repair between NM 45 (Coors Blvd) and Rio Grande Blvd. Also NM 45 (Coors Blvd) northbound and southbound on ramps to I-40 eastbound will have intermittent lane restrictions.

I-40 westbound & eastbound 98th to Rio Puerco:

Through October 6th from 9 P.M. to 5 A.M. I-40 westbound then eastbound will have nightly various lane and shoulder restrictions for maintenance operations.

October 20th at 9 P.M. through October 23rd at 5 A.M. weekends only continuous lane restrictions of I-25 southbound between (Indian School) milepost 226 and milepost 224 (Lead Ave) for bridge maintenance work. I-25 southbound off ramp to Lead/Coal will be closed. Detours will be established
