INDICTMENT

The Grand Jury charges:

Count 1

On or about August 12, 2016, in Doña Ana County, in the District of New Mexico, the defendant, **JESSE DENVER HANES**, with the intent to cause death and serious bodily harm, attempted to take a motor vehicle, specifically, a Ford Econoline truck bearing an Oklahoma license plate, that had been transported, shipped, and received in interstate commerce from Victim 1 and Victim 2 by force, violence, and intimidation.

In violation of 18 U.S.C. § 2119(1).

Count 2

On or about August 12, 2016, in Doña Ana County, in the District of New Mexico, the defendant, **JESSE DENVER HANES**, knowingly used, carried and brandished a firearm during and in relation to a crime of violence for which the defendant may be prosecuted in a court of the United States, specifically, Attempted Carjacking as charged in Count 1 of this indictment, and in furtherance of such crime, possessed and brandished said firearm.

In violation of 18 U.S.C. § 924(c)(1)(A)(ii).

Count 3

On or about August 12, 2016, in Doña Ana County, in the District of New Mexico, the defendant, **JESSE DENVER HANES**, with the intent to cause death and serious bodily harm, took a motor vehicle, specifically, a red 2015 Chevrolet Cruze bearing a Nevada license plate, that had been transported, shipped, and received in interstate commerce from Victim 3 by force, violence, and intimidation, resulting in serious bodily injury to Victim 3.

In violation of 18 U.S.C. § 2119(2).

Count 4

On or about August 12, 2016, in Doña Ana County, in the District of New Mexico, the defendant, **JESSE DENVER HANES**, knowingly used, carried, and discharged a firearm during and in relation to a crime of violence for which the defendant may be prosecuted in a court of the United States, specifically, Carjacking as charged in Count 3 of this indictment, and in furtherance of such crime, possessed and discharged said firearm.

In violation of 18 U.S.C. §§ 924(c)(1)(A)(iii), (c)(1)(C)(i).

Count 5

On or about August 12, 2016, in Doña Ana County, in the District of New Mexico, the defendant, **JESSE DENVER HANES**, having been convicted of the following felony crime punishable by imprisonment for a term exceeding one year:

(1) robbery;

knowingly possessed, in and affecting commerce, a firearm and ammunition:

- (1) a .45 caliber Kimber handgun bearing serial #KU265807; and
- (2) thirteen (13) rounds of Sig Sauer .45 caliber ammunition;

In violation of 18 U.S.C. §§ 922(g)(1) and 924(a)(2).
