Dear Dr Sam Sample,

This notice is sent to you in accordance with the requirements of the National Traffic and Motor Vehicle Safety Act.

Volvo Cars of North America, LLC (Volvo) has decided to conduct a voluntary safety recall on certain model year 2012 S60T5 vehicles.

The reason for Recall 243:

Under certain driving conditions, despite the fuel gauge indicating up to ¼ of the fuel remaining in the tank, the engine may not get enough fuel and the driver may notice engine hesitation and in a worse case scenario, the engine may stall. This condition can increase the risk of a crash.

The corrective action is to perform an Engine Control Module (ECM) software download.

What you need to do:

Please contact your authorized Volvo retailer for an appointment. This procedure will be completed at no cost and can take up to 30 minutes to complete; **however, due to service scheduling and parts availability, the time your Volvo retailer requires to service your vehicle may vary.**

If you had this repair performed before you received this letter, you may be eligible to receive reimbursement for the cost of obtaining a pre-notification remedy of the problem associated with this recall.
