**Roadwork Advisory Report – December 7<sup>th</sup>, 2017 through December 13<sup>th</sup>, 2017**

### **Interstate:**

#### **I-40 eastbound Project A300078R:**

Through January 2<sup>nd</sup>, 2018; Monday through Friday from 9 A.M. to 3 P.M I-40 eastbound will have various and shoulder restrictions in place for concrete repair between NM 45 (Coors Blvd) and Rio Grande Blvd. Also NM 45 (Coors Blvd) northbound and southbound on ramps to I-40 eastbound will have intermittent lane restrictions.

#### **I-40 eastbound Milepost 141:**

December 11<sup>th</sup> from 9 A.M to 3 P.M I - 40 eastbound at milepost 141 will have a right lane restriction for maintenance work.

Contractor: NMDOT.

#### **I-40 eastbound and westbound Milepost 152 to 155:**

Through December 12<sup>th</sup> from 9 P.M to 5 A.M I - 40 eastbound and westbound between milepost 152 to 155 will have a right and left lane restriction for maintenance work.

#### **I-25 northbound & southbound at Exit 230 (San Mateo Blvd) Project A301181:**

Through May 31<sup>st</sup>, 2018 I-25 NB & SB at Exit 230 (San Mateo Blvd) will have various shoulder and lane restrictions throughout the duration of the project.

I-25 southbound off ramp to San Mateo Blvd will be closed until further notice. Detours will be provided along I-25 southbound alerting motorists to exit at San Antonio or Jefferson.

San Mateo Blvd / Osuna Rd will have various lane and shoulder restrictions throughout the duration of the project.

#### **I-25 at NM 500 (Rio Bravo) Interchange Project A300280:**

Through summer of 2019; there will be continuous lane and shoulder closures /restrictions of NM 500 (Rio Bravo) and I-25 northbound and southbound. Work is being performed to facilitate a new NM 500 (Rio Bravo) Interchange with I-25.

#### **NM 45 SB at Hanover**
