INDICTMENT 3-17 CR-569-B

The United States Grand Jury charges:

Count One

Possession of a Firearm by a Felon [Violation of 18 U.S.C. §§ 922(g)(l) and 924(a)(2)]

On or about October 29, 2017, in the Dallas Division of the Northern District of Texas, the defendant, **Freddie Thomas Gilbert**, having been convicted of a crime punishable by imprisonment for a term exceeding one year, did knowingly possess in and affecting interstate commerce a firearm, that is a Taurus .38 caliber revolver, serial number 1E85960, in violation of 18 U.S.C. §§ 922(g)(1) and 924(a)(2).

Count Two Possession with Intent to Distribute a Controlled Substance [Violation of 21 U.S.C. § 841(b)(1)(C)]

On or about October 29, 2017, in the Dallas Division of the Northern District of Texas and elsewhere, the defendant, **Freddy Thomas Gilbert**, knowingly possessed with intent to distribute a mixture or substance containing a detectable amount of cocaine, a Schedule II controlled substance, in violation of 21 U.S.C. § 841(a)(1) & (b)(1)(C).

Forfeiture Notice [21 U.S.C. § 853(a); 18 U.S.C. § 924(d); 28 U.S.C. § 2461(c)]

The allegations contained in Counts 1 and 2 of this Indictment are hereby realleged and incorporated by reference for the purpose of alleging forfeitures pursuant to Title 18, United States Code, Section 924(d), Title 28, United States Code, Section 2461(c), Title 21 United States Code § 853(a).

Upon conviction for the offenses alleged in Count One of this Indictment and pursuant to 18 U.S.C. § 924(d), 28 U.S.C. § 2461(c), and 21 U.S.C. § 853(a), the defendant, **Freddie Thomas Gilbert,** shall forfeit to the United States of America all property, real or personal, constituting, or derived from, the proceeds obtained, directly or indirectly, as a result of the offense; and any property, real or personal, used or intended to be used, in any manner or part, to commit or facilitate the commission of the offense. Specifically, this includes the following firearms: a Taurus .38 caliber revolver, serial number 1E85960.

It also includes any holsters, ammunition, or other firearm accessories. If any of the property described above, as a result of any act or omission of the defendant[s]:

- a. cannot be located upon the exercise of due diligence;
- b. has been transferred or sold to, or deposited with, a third party;
- c. has been placed beyond the jurisdiction of the court;
- d. has been substantially diminished in value; or
- e. has been commingled with other property which cannot be divided without difficulty,

the United States of America shall be entitled to forfeiture of substitute property pursuant to Title 21, United States Code, Section 853(p).
