Some 2011MY Kia Sorento EX and EX V-6 vehicles with the Interior Accent Illumination option produced from October 23, 2009 through July 30, 2010.

573.6(C)(3) Total Number of Vehicles	Approximately 23,972 Model Year 2010 Kia Soul vehicles before application of the percentage identified in (C)(4). Approximately 11,213 Model Year 2011 Kia Sorento vehicles before application of the percentage identified in (C)(4).
<u>573.6(C)(4)</u> Percentage of Vehicles Estimated to Actually Contain the Defect:	The calculated incident rate for the vehicles identified in $(C)(2)$ is less than one percent (1%).
573.6(C)(5) Description of the Defect:	A limited number of wiring harnesses supplied by JCI and used for the lighting in the Kia Soul vehicle's Advanced Lighting Speakers, located in the front door trim panels, and the Kia Sorento vehicle's Interior Accent Illumination located in the front and rear door trim panels may have been improperly soldered. As a result, when the lights are illuminated under certain conditions, an electrical short may ensue, and can result in a fire.

Basis for Defect Determination:	In June 2010, KMA identified this issue during its review of field information. KMC then commenced an evaluation and analysis of the field information with the vendor.
	On August 23, 2010, KMC concluded that the product condition described in Section (C)(5) existed and warranted a safety recall.
	There is no report of accidents or injuries as a result of this condition.
573.6(C)(8)(i) Program to Remedy Defect:	All owners of vehicles identified in (C)(3) will be notified by first class mail to bring their vehicle to a Kia dealer. Kia will replace the wiring harnesses for the lights in the Kia Soul vehicle's Advanced Lighting Speakers, and the wiring harnesses for the Kia Sorento vehicle's Interior Accent Illumination located in the door trim panels to eliminate the possibility that this condition might exist.
