Dear Yokohama Tire Owner:

This notice is sent to you in accordance with the requirements of the National Traffic and Motor Vehicle Safety Act.


Yokohama Tire Corporation has decided that a defect which relates to motor vehicle safety exists in a small number of AVID Touring-S tires. These tires may have been produced with irregular geometry in the lower sidewall, above the tire bead area. Under certain circumstances, this can potentially create a condition in which loss of air pressure is possible, increasing the risk of a crash.

Our records indicate you may have purchased one or more of the specified tires. Please review this letter carefully to determine whether your tire(s) are affected and, if so, what actions to take to obtain replacement tire(s).

## **Affected Tire Range**

The tires included in the recall are limited to **one size of AVID Touring-S (215/65R16 98T)**, produced between February 2009 and April 2009.

The affected Tire Identification Number (TIN) ranges are detailed in the table below.

## What Should You Do?

If you own an AVID Touring-S tire in size 215/65R16 98T, please visit your local dealer at your earliest convenience for an inspection. If the dealer determines your tires are eligible for this recall, they will replace and mount the new tires for free.

Please bring this Notification Letter with you to the dealer, as it identifies that you may be eligible to obtain tire replacement service.

This campaign will expire 60 days from the date of this letter, so it is important that you act as soon as possible to determine whether your tires are covered by this campaign.
